Together, we reflected on how traumainformed spaces, like gardens, can offer safety, peace, and a sense of growth.



#### **Beat the Odds Awards**

The Prince William County Bar Association, in association with the **Prince William County Bar Foundation** and local government agencies, proudly sponsors the nationally recognized Beat the Odds® program, originally developed by the National Children's Defense Fund for the benefit of local youth. This annual program recognizes and encourages youth who have come in contact with the Prince William County juvenile justice system and have achieved academic and social progress in spite of tremendous odds against them. Each year, with financial support from the Prince William County Bar Foundation, \$40,000.00 in scholarships and awards are presented to deserving youth, affirming their achievements in the face of adversity and encouraging other youth in similar circumstances to strive to succeed.



This year, 25 youth were the recipients of awards -- two of them were nominated by CASA CIS. All of the award recipients have overcome much of the adversity that contributed to their initial need for intervention by the juvenile court. The scholarships and awards were presented at a banquet on May 20, 2025. It provided a wonderful opportunity for the community to show its support for these outstanding youth.

#### **Volunteer Appreciation Picnic and Presidential Service Awards**

Earlier this month we spent a wonderful afternoon celebrating some of our amazing CASA volunteers. As always, our staff had a great time hanging out with our advocates and meeting some of their families.
